- The child may be removed from activities
- Immediate pick-up may be required

UMCS reserves the right to dismiss a child at any time if the program is not a safe or appropriate fit.

- Tuition will not be refunded in the event of dismissal
- Future participation may be denied

UMCS may determine, at its sole discretion, appropriate placement for each child.
